

PROPOSITION 1: 2018-2019 SCHOOL BUDGET

Shall the following resolution be adopted? | Approval of Budget: Vote Yes or No

RESOLVED, that the proposed \$127,885,274 General Fund Budget of the Elmira City School District, Chemung County, New York for 2018-2019 be approved in accordance with Section 2022 of the Education Law and that the balance of said budget, after applying public monies thereto, be raised by a tax upon the taxable property of said district.

BOARD MEMBER ELECTION

District voters will elect three (3) members to the Board of Education. The three (3) candidates receiving the highest number of votes will be elected to three-year terms commencing July 1, 2018 and expiring June 30, 2021.



RECENT STAR EXEMPTION CHANGES

In 2016, the law changed regarding the STAR exemption. Instead of applying to your assessor for the exemption, you'll now register with New York State for the STAR credit. If you are eligible, you will receive a STAR credit in the form of a check. The dollar value of the credit will generally be the same as the property tax exemption. Please call NYS Department of Taxation and Finance at 518-457-2036 with questions or to register.

PROPERTY TAX INFORMATION

A proposed 1.5% tax levy increase will be presented to voters on May 15. Due to a decrease in Building State Aid, this rise is necessary to maintain current programs and services. This proposed increase is under the calculated tax levy limit of 4.25%.



NEW REQUIREMENT: REPORTING RESERVE FUNDS

Saving for future projects, acquisitions, and other allowable purposes is an important planning consideration for the Elmira City School District. You'll see a new report regarding reserve funds on page 5 of this newsletter. To summarize, reserve funds provide a mechanism for legally saving money to finance all or part of future infrastructure, equipment, and other requirements while mitigating the need to cut services or to raise taxes. The Elmira City School District is in compliance with the Real Property Tax Law limiting the amount of unexpected surplus funds to no more than 4% of the budget.



CHOOSING KINDNESS IN THE CLASSROOM: SUPPORTING ACADEMIC & EMOTIONAL WELLNESS

BEECHER ELEMENTARY

Every student at Beecher Elementary watched the film, Wonder, which promotes lessons on kindness, compassion and acceptance. The school has embraced the important life lessons taught from the movie by creating a Kindness Wall that is now on display in the cafeteria. Each student created a poster that included an inspirational quote and has the assignment of doing something kind.

RIVERSIDE ELEMENTARY

At Riverside Elementary, town meetings are focused around character traits such as **Respect**, **Responsibility**, **Tolerance**, **Citizenship** and **Kindness**. Students and staff spread kindness in school, home and the community in order to help grow the "Grinch Tree's Heart!" In turn, the Grinch helps student minds grow by asking them to read every night. Riverside takes emotional and educational learning to heart!

BROADWAY FI FMFNTARY

Broadway Elementary celebrated *Kindness Week* by participating in activities centered around *kindness* and *acceptance*. Staff creatively worked with students to publicly display and tally all of the acts of *kindness* completed by students. Students were also able to "Make & Take" *kindness* quotes from the *Kindness Confetti wall*.

ERNIE DAVIS ACADEMY

Through our Robotics and Engineering Course, students utilize underwater robotics to grow their knowledge of buoyancy, balance and understanding of robots. This course also brings the **opportunity** for students to learn about coding and to showcase their robotics skills in two different regional competitions.


PARLEY COBURN ELEMENTARY

Parley Coburn students and staff have been promoting **kindness** with an opportunity to recognize each other for kind actions. **Acts of kindness** are read during announcements and placed on an evergrowing garden of **Kindness Trees** in the cafeteria.











ELMIRA HIGH SCHOOL

High School students recently attended an assembly to hear from Mr. Larry Scott. Speaking on behalf of Rachel's Challenge, Mr. Scott shared the story of his late niece, Rachel Scott, the first fatal victim at Columbine High School. He delivered a message about kindness and compassion. Elmira High School accepted Rachel's Challenge as another step toward school safety. A Rachel's Challenge student group has been formed and a poster of commitment was signed by members. In May, this program will be brought to Broadway Academy and Ernie Davis Academy.

DIVEN ELEMENTARY

The Diven Dolphins have learned to be *Bucket Fillers* by purposefully using **kind words and actions** to make our school, community, and world a better place! The concept was introduced during a school-wide assembly and with the book, *Have You Filled a Bucket Today?* by Carol McCloud. During designated *Bucket Filler* days, students displaying **kind acts** are given a special coin to add to the school bucket.

PINE CITY ELEMENTARY

Each month, Pine City students participate in the Focus on Character program. Teachers look for students to demonstrate one of our six character traits: Trustworthiness, Respect, Responsibility, Fairness, Caring and Citizenship. Once selected for the month, a group picture is posted on the Focus on Character bulletin board in the hallway.

BROADWAY ACADEMY

Broadway Academy seventh grade students took the I AM NORM pledge, focusing on respect for all people and inclusion in our schools. The I AM NORM group shares gifts with their peers while encouraging acceptance and respect. Once a month, students meet to coordinate activities and share their ideas about how to promote inclusion in their school and community.

HENDY ELEMENTARY

The students and staff at Hendy Avenue are proud participants of the CATCH Program (Coordinated Approach To Child Health). The program promotes healthy food decisions, encourages daily physical activity, and endorses healthy lifestyle choices. Hendy partners closely with Cornell Cooperative Extension, local businesses, and other agencies to maintain a positive school environment.
